<u>AGENDA ITEM 3 – Approve minutes of 11-14-22, as circulated</u> – Motion was made by Trustees Crook/Yeager to approve the minutes from the 11-14-22 meeting. Motion was carried by a 5-0-1 roll call. Trustee Pflum abstained and Trustee Madigan was absent from meeting.

<u>AGENDA ITEM 4 – Public Comments</u> – Jaime Fairbank inquired about a chicken ordinance, if it has been approved, and if so how many chickens would be allowed. President Caramanidis stated that the ordinance has not been approved yet – hope to approve at the February meeting.

<u>AGENDA ITEM 5</u> – <u>Discuss Taylor Park improvements</u> – President Caramanidis mentioned that there is a possibility of a Taylor Park sign going up on Taylor Park Street – made possible by a generous donor/supporter. Trustee Crook gave an update with the Taylor Park west shelter project.

Mark Isaac thanked the Village Board allowing for allowing the freedom to design the Taylor Park Ball Diamond to his vision – with the help of the other groups that also use the diamond. He stated that everyone worked incredibly well – the Men's Softball, School and the Little League. Mark Isaac thanked Public Works Director Dan Holdridge over and over again and stated he loves Dan's attention to detail. Mark Isaac stated that he thinks people will probably come to Taylor Park in Rosendale to view our improvements when they want to do updates to their park/diamond. Mark also thinks that the Kids Fisheree played a major part with people seeing Taylor Park and its sense of community.
